Thank you for your interest in our Second annual Plein Air Event. This will be a 4-day event, painting from Thursday to Saturday, ending with a reception and sale on Sunday, June 23, 2019 at The Waters. Artists are invited to paint throughout the Oshkosh area.

Day 1, Thursday, June 20: The Paine Art Center and Gardens check-in and stamping from 9 AM -12 Noon. Fox River Brewing Co. 5 PM - 8 PM.

Day 2, Friday, June 21: Sunrise Paint at The Waters. 6 AM – 10 AM. PM The grounds of the Experimental Aircraft Association (EAA)

Day 3, Saturday, June 22: Oshkosh Farmers Market; late check-in and stamping from 7 AM – 12:30 PM. PM (TBD)

Day 4, Sunday, June 23: Patrons sale and reception will be at The Waters 10 AM – 1:00 PM.

Registration Fee: \$35 until May 31, 2019 and \$45 from June 1, 2019 until June 22, 2019

2019 Plein Air Festival Guidelines

- All work needs to be stamped prior to painting. Stamping will be done from 9 AM – 12 Noon on June 20, 2019 and from 7 AM – 12 Noon on June 22, 2019
- Painting must be done within the boundaries on map given out at check in.
- 95% of the painting must be done on-site in the true spirit of Plein Air Painting.
- **Registration limited to 30 artists (first to apply.)** Artists may participate in any or all events.
- Artists are required to attend the reception.
- Accepted media: Oil, acrylic, mixed media, watercolor, pastels, gouache, graphite, or pen and ink.
- Finished work must be archival framed and ready to hang. We reserve the right to reject any painting that is improperly framed, or painting not of professional standards.
- No piece can be larger than painted on a canvas that measure 20 inches in either width or height.
- All work entered in the show must have a visible stamp (works on paper can be shown to staff for approval before backing goes on or cut hole to show stamp.)
- Art must be delivered to The Waters between 8 AM and 9 AM, Sunday, June 23, 2019. Painting pickup will be at 1 PM.
- Paintings will be sold at the price determined by the artist. OFAA will receive 35% commission.
- One Award per Artist.
- Off-easel sales and selling of work previously painted are prohibited.
- Artists must display a minimum of 3 paintings and a maximum of 5 paintings.
- When a painting is sold, the artists may replace it with another painting.
- Paintings that have won an award will be moved to a separate area and need to remain at The Waters for the duration of the event.
- Registration fee is non-refundable and non-transferable.
- Feel free to bring your own floor or tabletop easels, marked with your name, to display your work.
