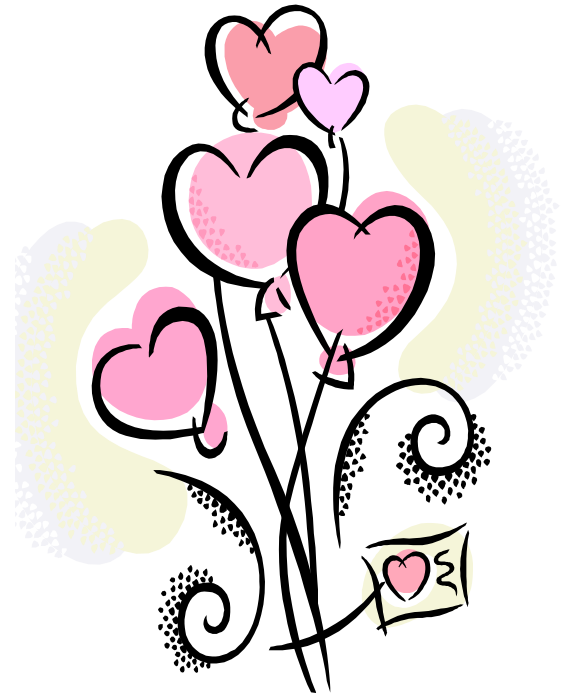

# Art in the Garden

## Call for Entries:

The Altrusa International Club of Oshkosh proudly presents their eighth annual juried Fine Art Show & Sale and would be pleased to have your participation. All proceeds from the event will benefit local charities and scholarships for students of the arts.

Hilton Garden Inn, 1355 W. 20<sup>th</sup> Avenue, Oshkosh, WI 54902

March 29 & 30, 2014

## Exhibition Time:

Saturday 12:00pm - 5:30pm & Sunday 10:00am - 4:00pm

## Artist's Reception:

Saturday evening 6:00pm to 8:00pm

## Eligibility:

All artists 18 years & older. All entries must be recent & original works created by the artist exhibiting.

## Entries:

Artists may enter up to 3 entries. All artwork is to be juried; no substitutions; acceptance letter to follow. All artworks must be properly framed and securely wired for hanging. Dimensions of 2-D work must not exceed 40" by 40". Three-dimensional artwork must come with appropriate supports or cases for display on table tops. Please indicate on the reservation form if you have unusual display needs. All artwork must have an identification form attached to the back of the work to identify Artist, Title of Work, Medium, Category and Price. All artwork entered into show must remain part of the display for the entire two days.

## Entry Fees:

Maximum of 3 entries: \$40 fee for first entry, \$45 for two entries, & \$55 for 3 entries. All 3 entries will be displayed unless space becomes limited. Fees must accompany registration form and will not be refundable.

## Jury Information Registration:

All artwork is to be juried by means of photograph or digital image (no CDs or slides please) and sent with entry form to: Art in the Garden, c/o Cheryl McCarthy, 1491 S. Oakwood Rd, Oshkosh, WI 54904, or digital images via email to: [ame@vixendesigns@shoglobal.net](mailto:ame@vixendesigns@shoglobal.net). Deadline for entries is March 1, 2014. The jury committee reserves the privilege of rejecting work that does not conform to show specifications or differs greatly from submitted photos or digitals. Absolutely no changes to title, medium and price, etc. allowed after March 10, 2014.

## Mediums:

Original work in Oil, Acrylic, Watercolor, Tempera, Pastel, Pencil, Ink, Charcoal, Mixed Media, Carving, Photography, Pottery & Sculpture, Glass Art, Jewelry and Fiber.

## Judges:

This is a People's Choice Show where the public is the judge. They will be voting by ballot for their favorite artworks in 2-D and 3-D as they view the show. Votes will be tallied and awards given for the piece with the highest number of votes. Voting will begin at 12:00 pm on Saturday and end at 2:00 pm on Sunday. Awards will be given out between 3:15-4:00 pm on Sunday.

## Awards:

**\$2,300 in cash awards** are sponsored by generous area businesses, individuals, & organizations and will be awarded to artists by categories as listed below:

- (1) People's Choice Best of Show – \$400
- (1) Altrusa Award – \$300
- (1) Bev McCarthy Memorial Award - \$250

Awards based on the following entry categories and there will be 3 awards totaling \$450.00 in each category:

**Category I** – Open to all artists considered professional or all artists who generate 25% or more of their income through the sale of artwork.

**Category II** – Open to all artists who have won a ribbon at Art In The Garden in the previous two years – 2012 or 2013

**Category III** – Open to all artists who are not professional artists or have not won a Ribbon at Art In The Garden in the previous two years – 2012 or 2013
